RESOLUTION NO. 24-22

A RESOLUTION TO PROVIDE NOTICE OF INTENT TO CREATE A BUSINESS IMPROVEMENT DISTRICT

WHEREAS, THE CITY OF BOX ELDER has received a petition from the majority of the landowners within the proposed district, pursuant to SDCL 9-55-9, to form a Business Improvement District pursuant to the provisions of SDCL 9-55, et seq., and

WHEREAS, in consideration of said petition, the Common Council intends to create a Business Improvement District, and

NOW THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BOX ELDER that the Common Council hereby gives its Notice of Intent, pursuant to the provisions of SDCL 9-55-7, to create a Business Improvement District #3 as set forth in said petition as follows:

- A. The boundaries of the proposed District include the properties described as follows:
- 1. Atlantis LLC "LaOuinta Inn & Suites" parcel (a/k/a 1416 N. Elk Vale Rd., Rapid City, SD 57703. Note: address is "Rapid City" but land is located within Box Elder municipal limits):
 - Lots 1 & 2 of Davis Subdivision, Section 27, Township Two North (T2N), Range Eight East (R8E), Black Hills Meridian (B.H.M.) Box Elder, Pennington County, South Dakota;
- 2. <u>Atlantis LLC "Residence Inn by Marriott" parcel (a/k/a 581 Watiki Way, Box Elder SD 57719):</u>

- B. A hearing will be held on November 19, 2024, in the Council Chambers of the Box Elder City Hall to consider the establishment of such District;
- C. The funds generated from such District may be used for the following:
 - A. Maintenance, repair and reconstruction of improvements or facilities authorized by SDCL 9-55, et seq;
 - B. Projects or undertakings for the betterment of the facilities in the District area, whether the project is capital or noncapital in nature;
 - C. Employment or contracting for personnel, including administrators for improvement or promotional programs under SDCL 9-55, et seq., and providing for services necessary or proper to carry out the purposes of SDCL 9-55, et seq.

- D. The proposed or estimated costs for improvements, facilities and activities within the District described above, are Five Hundred Thousand Dollars (\$500,000.00) per year; and
- E. The method of assessment within the District shall be fair and equitable and shall be based on rooms rented by any lodging establishment to transient guests within the District, not exceeding the maximum allowed by SDCL 9-55-7, which currently is Two Dollars (\$2.00) per occupied room per night.
