RESOLUTION NO. 24-25

A RESOLUTION RENAMING 228 STREET TO CHEYENNE BOULEVARD WITHIN THE JURISDICTION OF THE CITY OF BOX ELDER, PENNINGTON COUNTY, SOUTH DAKOTA

WHEREAS, New development along what is currently known as 228 Street will require addressing once completed; and

WHEREAS, it is timely and appropriate to rename the roadway prior to completion of the new development in order to streamline address allocation and enhance wayfinding for residents, emergency services, and future developments in the area; and

WHEREAS, the section of roadway as shown in attached Exhibit A and currently known as 228 Street, from Radar Hill Road west +/- 1,138 feet, is adjacent to the properties legally described as follows:

Lot 7, Block 1, Flying Eagle Ranchettes, Section 25, T2N, R8E, City of Box Elder, Pennington County, SD

Lot 8, Block 1, Flying Eagle Ranchettes, Section 25, T2N, R8E, City of Box Elder, Pennington County, SD

Lot 1 of Southeast Quarter of the Southeast Quarter, Section 25, T2N, R8E, Pennington County, SD

Tract 1R, Cheyenne Pass, Section 36, T2N, R8E, City of Box Elder, Pennington County, SD


Northeast Quarter of the Northeast Quarter LESS Cheyenne Pass, LESS Lot H2, and LESS Right-of-way, Section 36, T2N, R8E, City of Box Elder, Pennington County, SD

Tract 2R, Cheyenne Pass, Section 36, T2N, R8E, City of Box Elder, Pennington County, SD.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Box Elder, that 228 Street as above described is hereby renamed to "Cheyenne Boulevard".

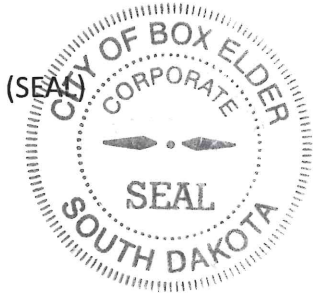
