Section Two

That there is hereby levied on all taxable property within the City of Box Elder, South Dakota for the purpose of providing funds to meet the lawful expenses and liabilities of the City of Box Elder, South Dakota, as set forth, for the Fiscal year 2010, a tax sufficient to raise the following amount, which is to be received by the City Finance Officer and credited to the following funds:

General Fund \$ 596,708.00

For General Municipal Purposes \$596,708.00 divided by taxable valuation of \$139,744,344.00(Pennington) and \$7,508,897 (Meade) equals a mill levy of \$4.60

Section Three

The City Finance Officer is hereby authorized and directed to certify the dollar amount of the property tax levies stated in this ordinance to the Pennington County Auditor.


Section Four


